Part 2: Please complete the sentences by using the words given: (30%) agency, balance, budget, denominate, impose, lag, maturity, speculation, structure, subprime (每題三分, 請使用正確的形式, 如因動詞形態或名詞單、複數錯誤, 則該題將扣一分) The Financial Supervisory Commission (FSC) has announced that Foreign Institutional Investors (FINIs) or Foreign Individual Investors (FIDIs) are allowed to invest in TWD or foreign currency (1) equity or interest rate linked products available on the GreTai Securities Market (GTSM). These (2) products are subject to the 30% fund usage control (aggregate investment amounts must not exceed 30% of the total net remitted-in capital) (3) foreign investors. Bonds with a remaining _____(4)___ of more than one year are excluded from the 30% fund usage control. The Central Bank, on March 11, 2008, reiterated that funds remitted by foreign investors should be used for securities investment only. In order to avoid the local currency market, excessive _____ (6) ____ in cash accounts shall not be maintained for long periods by FINIs or FIDIs. U.S. and European media stocks have been hammered almost as much as many of the banks caught in the (7) mortgage crisis. The biggest factor weighing on media stocks is concern that advertising will slow. It isn't clear how hard ad (8) will be hit, but there are signs it probably won't be a complete rout. Typically, advertising expenditure follows changes in economic growth with a six-month _____(9) ____. That suggests advertising should slow significantly in the second half of this year. But large advertising (10) companies in Britain and Europe say they are expecting a good 2008, driven by the Beijing Olympics and the European soccer championship.

In March 2008, executives and lawyers representing Intel Corp. appeared before European Commission officials in an effort to avoid antitrust action by the European regulator, which suspects the company of anticompetitive practices. The EU filed preliminary charges against Intel in July last year, alleging the company offered rebates to customers only if they didn't use AMD products, paid customers to delay the launch of AMD-based products and sold its chips below cost to undercut AMD. In the future, the EU will probably examine the nature of any rebates or payments, which an AMD spokesman described as 'payments for exclusivity.' It is also possible that the commission could object to Intel's rebates simply because the company controls most of the market.
